RELEASE OF SHARES FROM ESCROW APPENDIX 3B QUOTATION OF SECURITIES

Attached is an Appendix 3B for the application for quotation of the securities that were released from escrow on 9 December 2012.

On 5 December 2012 Indochine made an announcement in accordance with Listing Rule 3.10A concerning the release from escrow of 81,976,476 fully paid ordinary shares classified by ASX as restricted securities (released on 9 December 2012). As required by Listing Rule 2.8.2, Indochine Mining Limited now applies for quotation of these 81,976,476 shares. This will maintain the total number of ordinary shares on issue at 722,483,322.

Secondary Trading Exemption

The Act restricts the on-sale of securities issued without disclosure, unless the sale is exempt under section 708 or 708A. By the Company giving this notice, a sale of the Securities noted above will fall within the exemption in section 708A (5) of the Act.
